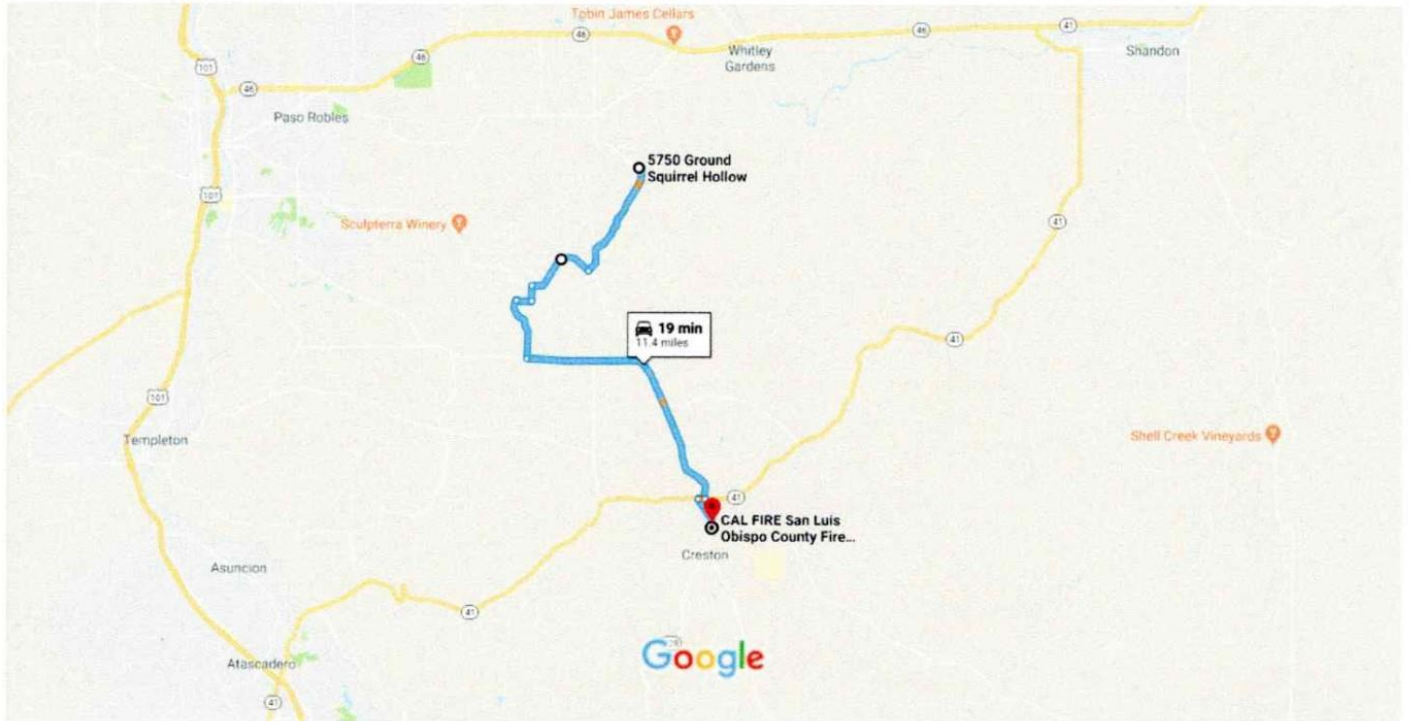

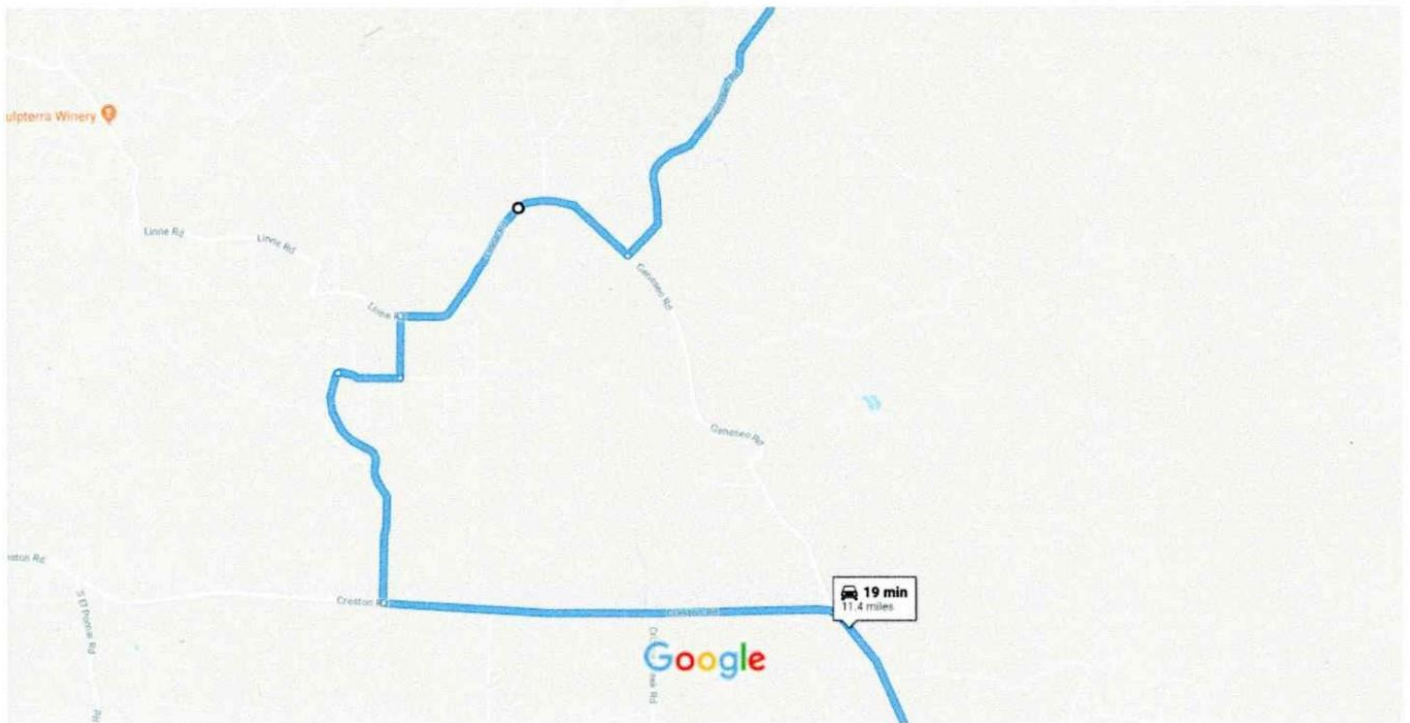


5750 Ground Squirrel Hollow, Paso Robles, CA Drive 11.4 miles, 19 min
